## I. PRIVACY POLICY AND DATA PROTECTION

Respecting the provisions of the current legislation, **allPlanning Solutions** (hereinafter also referred to as "the Website") commits to adopting the necessary technical and organizational measures to ensure the appropriate level of security for the collected data.

### Laws Incorporated in This Privacy Policy

This privacy policy is adapted to current Spanish and European regulations regarding personal data protection on the internet. Specifically, it complies with the following laws:


- **Regulation (EU) 2016/679** of the European Parliament and of the Council of April 27, 2016, on the protection of individuals regarding the processing of personal data and the free movement of such data (**GDPR**).
- **Organic Law 3/2018**, of December 5, on the Protection of Personal Data and the Guarantee of Digital Rights (**LOPD-GDD**).
- **Royal Decree 1720/2007**, of December 21, approving the Regulation for the development of Organic Law 15/1999, of December 13, on the Protection of Personal Data (**RDLOPD**).
- **Law 34/2002**, of July 11, on Information Society Services and Electronic Commerce (**LSSI-CE**).

### Personal Data Registration

In compliance with **GDPR** and **LOPD-GDD**, we inform you that personal data collected through forms on **allPlanning Solutions** will be included in our database to **facilitate, manage, and fulfill commitments** established between **allPlanning Solutions** and the user. The collected data will also be used to maintain any relationships established through these forms, respond to inquiries, or provide requested services.

Unless an exemption applies under **Article 30.5 of the GDPR**, we maintain a record of processing activities detailing the purpose, processing activities, and other relevant legal aspects.

## Principles Applicable to the Processing of Personal Data

The processing of user data will adhere to the following principles as stated in **Article 5 of the GDPR** and **Article 4 of Organic Law 3/2018**:

- **Lawfulness, fairness, and transparency:** User consent will always be required with **clear and transparent** information on data collection purposes.
- **Purpose limitation:** Data will be collected for specific, explicit, and legitimate purposes.
- **Data minimization:** Only **strictly necessary** personal data will be collected for the intended purpose.
- **Accuracy:** Personal data must be **accurate and up-to-date**.
- **Storage limitation:** Data will be retained **only for the necessary duration** of its intended purpose.
- **Integrity and confidentiality:** Personal data will be processed **securely and confidentially**.
- **Proactive responsibility:** The data controller is responsible for ensuring compliance with the above principles.

---

## Categories of Personal Data

The only type of personal data processed by **allPlanning Solutions** is **identification data**. **No special categories of personal data** (as defined in **Article 9 of the GDPR**) are processed.

---

## Legal Basis for Data Processing

The **legal basis** for processing personal data is **user consent**. **allPlanning Solutions** commits to obtaining explicit and verifiable consent for **specific purposes**.

The user has the right to **withdraw consent at any time**. Withdrawal of consent will **not affect** the lawful processing carried out before the withdrawal.

When users provide personal data via forms for inquiries, information requests, or content-related reasons, they will be informed if completing the form is **mandatory** for proper service delivery.

---

## Data Retention Periods

Personal data will be retained for the **minimum time necessary** to fulfill the intended purpose, but in no case longer than **three (3) months**, unless the user requests its deletion.

At the time of data collection, users will be informed about the **specific retention period** or the **criteria** used to determine it.

## Data Recipients

User data may be shared with the following recipient or category of recipients:

If **allPlanning Solutions** intends to transfer data to a third country or international organization, the user will be informed beforehand about the recipient, legal safeguards, and any relevant adequacy decisions by the European Commission.

## Data Security Measures

**allPlanning Solutions** commits to implementing **technical and organizational measures** appropriate to the **level of security** required to protect collected data from unauthorized access, destruction, or modification.

The website is secured with an **SSL certificate** (Secure Socket Layer) to ensure that data transmission between the user and the server is encrypted and confidential.

However, **due to the nature of the internet, absolute security cannot be guaranteed**. In case of a **security breach** that poses a **high risk** to users' rights, **allPlanning Solutions** will **immediately notify affected users** as required by **Article 4 of the GDPR**.

## User Rights

Users have the following rights under the **GDPR** and **LOPD-GDD**:

- **Right of access:** The right to obtain confirmation of whether **allPlanning Solutions** is processing personal data and to access such data.
- **Right to rectification:** The right to correct inaccurate or incomplete personal data.
- **Right to erasure ("right to be forgotten")**
- **Right to restriction of processing**
- **Right to data portability**
- **Right to object**
- **Right not to be subject to automated decision-making, including profiling**
